

City of Grande Prairie Recreation & Transit Access Program

The recreation and transit access programs are available to qualifying individuals and families living in the City of Grande Prairie. These programs provide opportunities to improve health, well-being and access to community services, by reducing financial barriers.

RECREATION ACCESS PROGRAM

The Recreation Access Program is a program to help ensure all residents have access to leisure, recreation and fitness opportunities. We value providing socially inclusive programs to each individual and family in Grande Prairie. Providing this program to eligible participants removes financial barriers while enhancing community and family connectedness.

The program offers a 75% subsidy on Eastlink Centre memberships and passes to qualifying applicants. This enables participants to access the facilities for only 25% of the regular admission price.

TRANSIT ACCESS PROGRAM

The Transit Access Program helps to ensure all residents of Grande Prairie have access to public transit and can stay connected to their community.

It offers a 50% subsidy on the Grande Prairie Transit SUPERPASS to qualifying applicants.

APPLICATION PROCESS

1. Call 780-538-0300 to book an application appointment at the City Hall or apply online.
2. You must bring/ upload:
 - o A completed application form (download online at cityofgp.com/RAP, cityofgp.com/TAP or pick up a paper copy at participating facilities)
 - o 1 document showing proof of age for each dependant (birth certificate, baptismal certificate OR Alberta Health Card)
 - o 1 document showing proof of address (current utility bill, current bank or credit card statement, government-issued letter, driver's license OR Alberta Government Identification Card)
 - o 1 document showing proof of household income - this includes yourself, your partner, spouse and dependant children 18 years of age or older (Current Alberta Income Support Direct Deposit Statement, 2020 Notice of Assessment OR your 3 most recent paystubs)

The application appointment takes about 15 minutes and there is no waiting period before approval.
